TERMS & CONDITIONS

These are the Terms and Conditions that apply to the NZB Airfreight Triple Crown Series.

1.0 INTERPRETATION

1.1 Definitions

In these Conditions, unless the context requires otherwise:

GST means Goods and Services Tax;
NZB means New Zealand Bloodstock Limited;

HRNZ means Harness Racing New Zealand.;

Registered means registered with HRNZ

Rules of Racing mean the New Zealand Rules of Racing administered by HRNZ;

Win includes a dead heat;

These Conditions means these terms and conditions;

The NZB Airfreight Triple Crown comprises the races as set out in the schedule under the heading Schedule;

1.2 Construction

In the interpretation of these Terms and Conditions, unless the context

otherwise requires:

(a) Any reference to a person shall include reference to a body corporate and to an unincorporated body of persons;

(b) Words importing the singular shall include the plural and vice versa.

(c) Words importing one gender shall include the other genders.

2.0 BONUS PAYMENT

Subject to these conditions NZB shall pay a prize of \$100,000 (including GST if any) to the registered Owner or Lessee of a horse that wins all three races comprising the Triple Crown Series.

3.0 CONDITIONS

These conditions apply to the payment of the prize for each Triple Crown Series ("the Series") respectively:

3.1 Owner/Lessee

(a) The prize shall be paid to the registered Owner/Lessee of the horse at the time of the running of the third race of the Series; and

(b) The same horse must win all three races comprising the Series.

3.2 Number of Races

The series must comprise three races, if for any reason a race is not run, the prize will not be payable.

3.3 Number of Starters

Each race of the series must have not less than 8 starters. If for any reason a race has less than 8 starters at the jump, the prize will not be payable.

3.4 Dead Heats

In the unlikely event of three dead heats the prize will be shared equally between the dead heaters.

3.5 The Winner

The winner of a race shall be the horse(s) that is finally determined as the winner following the running of the race and the application and completion of all judicial procedures applicable thereto pursuant to the Rules of Racing. Should the prize be paid to a person who is not entitled to the prize, the prize is immediately repayable by the recipient to NZB as a debt due.

3.6 Rules of racing


Other than in respect of the payment of a prize by NZB the Series races are to be conducted in accordance with the Rules of Racing.

4.0 DISPUTES

The Prize is awarded by NZB is without consideration and in the event of any dispute or difference concerning the prize or entitlement to the prize the dispute or difference shall be resolved by NZB and the decision of NZB shall be final and binding on NZB and the parties to the Dispute or difference.
